10 APPOINTMENT OF INDEPENDENT PERSON

The Monitoring Officer reported that the term of office for Mr Oram, the Independent Person to the Standards Committee would expire in November 2016. The Monitoring Officer reported that four people had responded to the advertisement and Mr Oram, was one of the respondents. Great Yarmouth Borough Council was now legally able to appoint an Independent Person as the position has been advertised.

A Member felt that an interview process should be undertaken to ensure that the Council adhered to its transparency policy. However, the majority of Members felt that Mr Oram had always offered sound advice to the Committee and he should therefore be reappointed in November.
