1. Introduction

1.1. The purpose of those reports is twofold — it is intended to provide the Council with an awareness and understanding of the current activity of the outside body and to understand how this aligns with the Council's corporate priorities; accordingly, this provides information for the Council to review (at Policy & Resources Committee) whether the appointment should continue
