#### **Belton with Browston Parish Council**

1. What are the facts about recycling bins being sent to land fill and incineration from the villages.
2. What are the future plans for the Compass Centre in Belton.

#### **Bradwell Parish Council**

1. Outstanding 'commuted sums' of 'Section 106' Monies - request for a more formalised meeting arrangement for dealing with requests from relevant parishes for such sums of money to be spent in a particular way.

#### **Burgh Castle Parish Council**

1. Requested that the meetings in future do not clash with their Parish Council Meetings.

### **Caister Parish Council**

1. Why has the Borough Council not approved any actions towards a climate emergency?
2. Beach Road Car Park - of the money collected in the past from parking and all the money spent filling potholes, which do not last, why can the car park not be resurfaced properly?

### **Hopton Parish Council**

1. Please confirm that S106 money from the proposed Links Road development, which is situated in the Parish of Hopton, will be allocated for use in Hopton and not Gorleston. The Parish Council would like to be consulted in relation to the S106 money as early as possible in the negotiations.

### **Martham Parish Council**

1. Integration - for example integration of services across the villages where housing developments affect the residents of surrounding villages i.e. increase inattendance to schools in another village which then has an impact on traffic etc.

### **Mautby Parish Council**

1. An up to date contact details list of key officers and their responsibilities.

### **Ormesby St Michael Parish Council**

1. Concerned at the continued absence of reports from the local constabulary regarding issues within the parish despite persistent requests. Can the borough council assist?
