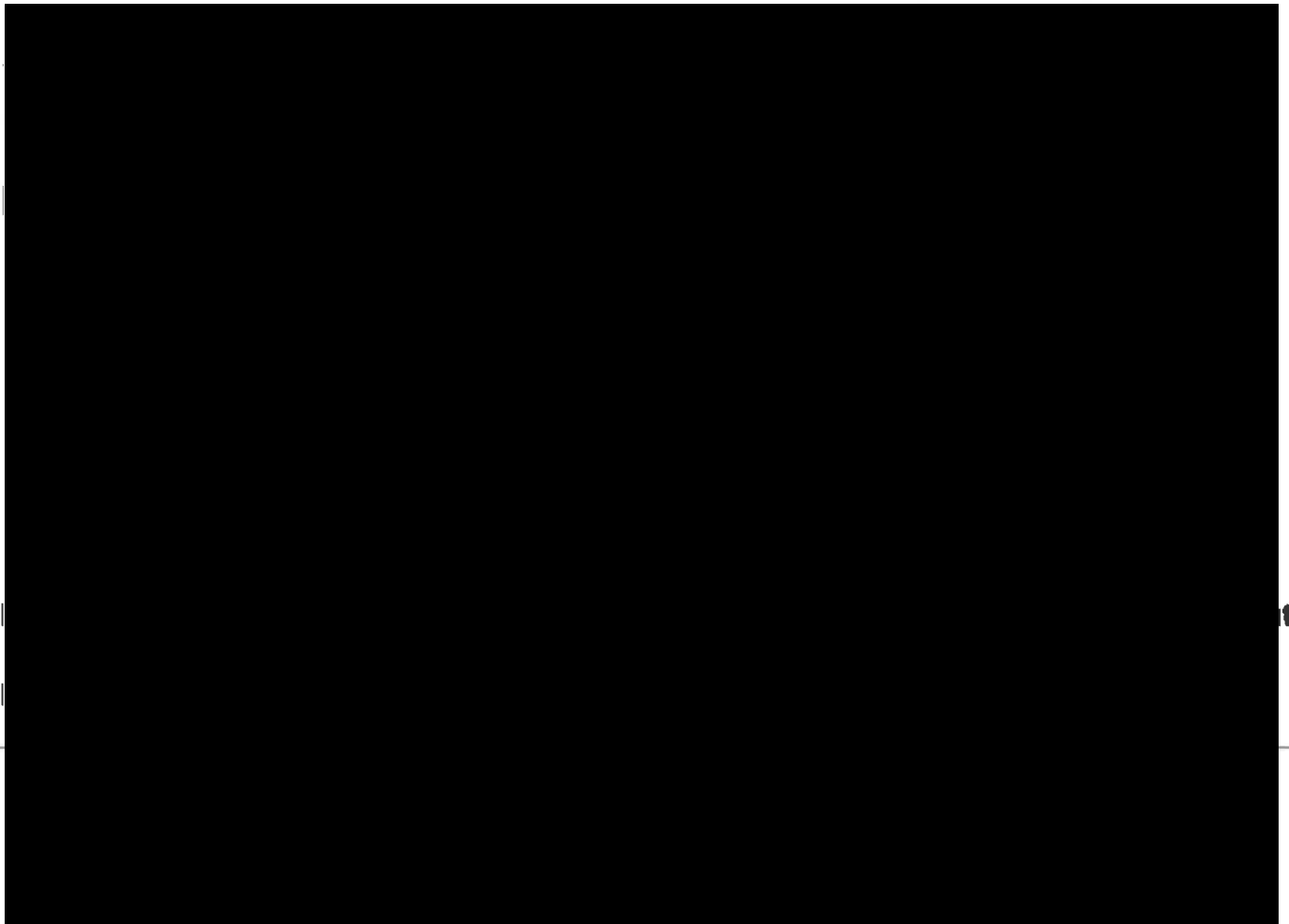

- (4) fail to provide written notification to the Council's Monitoring Officer of any change in my disclosable pecuniary interests as soon as possible.
