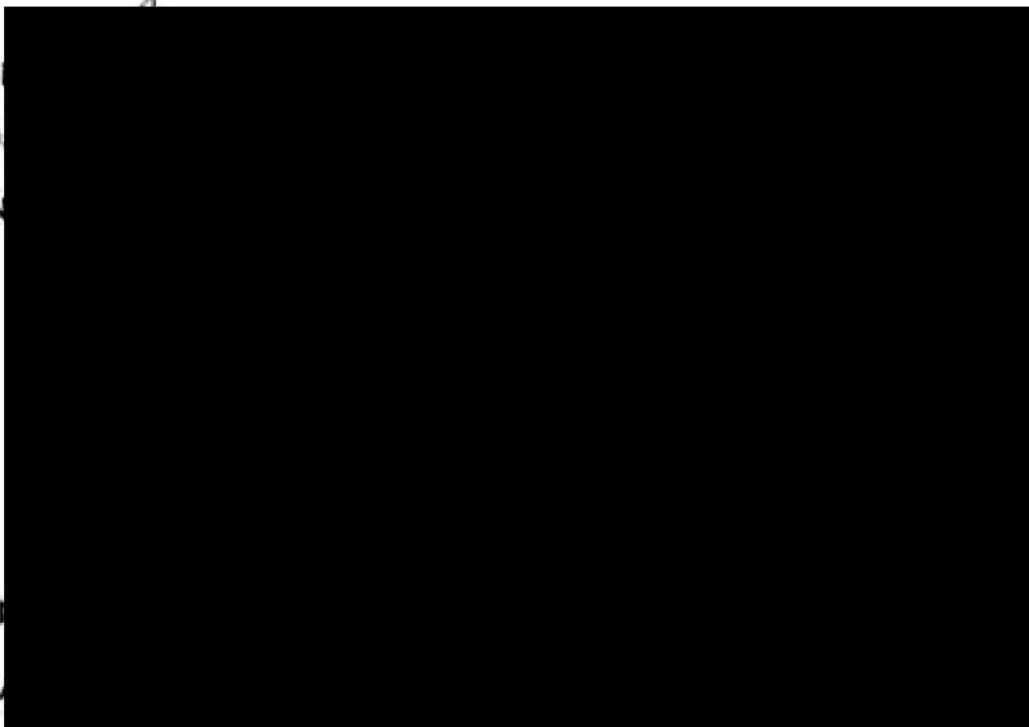
I acknowledge that it may be an offence under the Localism Act 2011 to:-
