Title: Application to vary a premises licence to specify an individual as

Tramway Public House, 1 Lowestoft Road, Gorleston, Great Yarmouth

#### **Summary and Conclusions:**

This report concerns a premise known as Tramway Public House, 1 Lowestoft Road, Gorleston, Great Yarmouth. The premises licence holder, Flavio Fernandes, has applied to vary the premises licence to specify Lydia Jones as the designated premises supervisor. The Police have submitted an objection to the application.

#### Report

#### 1. The Application

- 1.1 On 15 June 2021, the Licensing Authority received an application, submitted by Flavio Fernandes, to vary the premises licence of Tramway Public House, 1 Lowestoft Road, Gorleston, Great Yarmouth to specify Lydia Jones as the designated premises supervisor. The application was to have immediate effect. A copy of the application is attached.
- 1.2 The designated premises supervisor authorises the sale of alcohol at a premise. The designated premises supervisor must hold a personal licence. Lydia Jones has held a personal licence since 14 May 2021.
- 1.3 A copy of the current premises licence in relation to Tramway Public House is attached.

#### 2. Representations

- 2.1 In accordance with licensing act requirements, a copy of the application was sent to the police. The police can give notice to the licensing authority if satisfied that the exceptional circumstances of the case are such that granting the application would undermine the crime prevention objective.
- 2.2 On 22 June 2021, the licensing authority received a notice from the police objecting to the application. A copy of the objection is attached.

#### 3. Options available to the Sub-Committee

- 3.1 Grant the application to vary the premises licence to specify Lydia Jones as the designated premises supervisor.
- 3.2 Refuse the application to vary the premises licence to specify Lydia Jones as the designated premises supervisor.

#### 4. Recommendation

It is recommended that the Sub-Committee determines the application to vary the premises licence to specify Lydia Jones as the designated premises supervisor in accordance with one of the options set out in paragraph 3 above.

#### MANDATORY CONDITIONS RELATING TO THE SUPPLY OF ALCOHOL (ON-SALES)

- 1. No supply of alcohol may be made under the premises licence:
  - At a time when there is no designated premises supervisor in respect of the premises licence, or
  - At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

- 3. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 4. An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:
  - (a) Games or other activities which require or encourage, or are designed to require or encourage, individuals to:
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that person is unable to drink without assistance by reason of disability):
- 5. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 6. (a) The premises licence holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (b) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age

verification policy.

(c) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either -

a holographic mark or an ultraviolet feature.

- 7. The responsible person must ensure that:
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- 8. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 9. For the purposes of the condition set out in paragraph 9-
  - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty

- were charged on the date of the sale or supply of the alcohol, and

  (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol:
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 10. Where the permitted price given by Paragraph (b) of paragraph 10 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 11. -(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 10 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- during the first twenty minutes after the permitted hours, the taking of the alcohol from the premises unless the alcohol is supplied or taken in an open vessel;
- consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
- the ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered:
- the sale of alcohol to a trader or club for the purposes of the trade or club;
- the sale or supply of alcohol to any canteen or mess, being a canteen in which the sale
  or supply of alcohol is carried out under the authority of the Secretary of State or an
  authorised mess of members of Her Majesty's naval, military or air forces;
- the taking of alcohol from the premises by a person residing there; or
- the supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
- the supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

#### Embedded benefit under the Private Places of Entertainment Act, 1967

This licence also allows the provision of private entertainment for private gain, being dancing, music or any other entertainment of a like kind.

#### **Conditions Consistent with the Operating Schedule**

#### **Prevention of Crime and Disorder**

The Licensee can extend the licensable hours up to a maximum of 30 occasions per calendar year. Each occasion must not exceed one calendar day. Notification must be given, five working days in advance by email, to the Police Licensing Team and Great Yarmouth Borough Council Licensing Team.

On days when the licensable activities are extended for up to 30 occasions, the designated premises supervisor will be present at all times during the extended opening hours and until the premises are closed for business.

On days when the licensable activities are extended for up to 30 occasions, there will be no entry by any person to the premises after 01.30 hours except for existing customers returning

from the smoking area. Notices to that effect will be prominently displayed at the entrances to the premises.

On days when licensable activities are extended for up to 30 occasions, the premises licence holder (or their representative) shall ensure that there are sufficient trained members of staff on duty at the premises able to deal with the number of customers likely to be on the premises during those extended hours. A detailed written assessment of the risk associated with the extended opening will be prepared and made available to the police on demand.

The Manager is to live on the premises with effect from 17 January 2013.

A minimum of seven CCTV cameras, positioned inside and outside the premises, will be in operation on a 24 hour basis. Recordings will be kept for at least one month and will be provided to the Police on request.

An incident book will be kept at the premise, hard back, bound and with numbered pages which will be made available to the Police on request and will include refusals of service.

The premises licence holder shall join the Night Safe Scheme if requested to do so.

The premises licence holder will keep a written record of staff training which will be provided to the Police and the Licensing Authority upon request.

There is to be a drug and public house policy in place.

#### **Prevention of Public Nuisance**

Noise or vibration from amplified music will not be audible at the façade of residential properties in the neighbourhood

The volume of the music will be progressively diminished from 02.00 on Friday and Saturday nights.

Perimeter checks will be carried out after 23.00 to assess the amount of noise being emitted from the premises. Details of the times of these checks and any action taken will be recorded contemporaneously.

No entry will be permitted on to the premises after 02.00.

A member of staff will be in control of the volume regulation for the music at all times that music is being played.

The entertainment will consist of amplified devices including a karaoke machine and other recorded music equipment under the control of the manager and staff. No musical instruments will be used by performers in any of the entertainment after 01.00am.

All windows and doors facing residential property will be closed during performances. Windows facing residential properties will be fitted with suitably heavy drapes/curtains to reduce noise emission.

Clear, legible and prominent notices will be displayed at all exits requesting persons to leave the premise and area quietly

The placing of refuse, including glass bottles into receptacles outside the premises must be carried out at a time which does not cause a public nuisance to neighbouring residents

The playing of live or recorded music must not take place outside of the premises

The garden or outside area is not to be used after 23.00pm so as not to cause public nuisance to residential properties in the neighbourhood

Any security or other lighting must be designed and/or operated so that it does not cause a public nuisance

Smoking will be restricted to the back of the premises

#### **Public Safety**

There is to be signage with regard to emergency exits

#### **Protection of Children from Harm**

No children (16 years of age or younger) will be permitted on the premises after 23.00 hours.

The 'challenge 25' proof of age scheme will be operated at the premises.

I can confirm that Police have received the application to vary the premises licence to specify a Designated Premises Supervisor and the DPS consent form for the above premises.

Police raise an objection to this application. Inspector Catton writes: -

"Since the premises opened up on 12<sup>th</sup> April when Covid restrictions allowed there have been endless problems and numerous calls for service following reports of violence, Covid breaches and anti-social behaviour

The local residents are angered by the poor running of the premises. The premises is in a residential area and when patrons leave in the early hours, they are significantly disrupting the locals. The local councillor is involved and I am aware that there have been a number of complaints made to them and also to me.

This is an issue which cannot continue and I see no option other than to object to the variation on the grounds that the proposed new DPS has been at the premises since it opened and each week we have had reported issues"

Given the number of calls received and the nature of the incidents reported, including several for disorder and patrons assaulted; the nominees ability to supervise effectively is demonstrably inadequate. To this end police object to this nomination.
