Register of Members' Interests

3. Securities

Any beneficial interest in securities of a body where:

- (1) that body (to your knowledge) has a place of business or land in the area of the Council; and
- (2) either-
 - (a) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - (b) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issue share capital of that class.

Personal or Local Non-Pecuniary Interests

1. Any matter being considered at a Council or Committee meeting when it is not a Disclosable or Pecuniary Interest but a decision on it is likely to affect:-

a. well being or your financial position

b. that of a family member or close friend

c. that of a club or society in which you hold a management role

d. that of another public body of which you are a member to a greater extent than others in your ward

I acknowledge that it may be an offence under the Localism Act 2011 to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to give further notices in order to bring up to date information given in this notice after my election or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.

I also acknowledge that it may be a breach of the Code of Conduct to:-

- (1) fail to notify the Monitoring Officer of any Disclosable Pecuniary Interests within 28 days of taking office by completing the register form.
 - (2) omit information that ought to be given in this notice;
 - (3) provide information that is materially false or misleading;
 - (4) fail to provide written notification to the Council's Monitoring Officer of any change in my disclosable pecuniary interests as soon as possible.
